I highly appreciate to be kept informed of progress in this continued investigation.

Dear President,

I am writing to you because I am deeply concerned about the safety of Carlos Hernández and his colleagues at the “Association for a More Just Society” (ASJ) due to the threats and intimidation against them.

Welcoming the arrests made in January 2008, I would like to express hope that the trial of the accused will proceed swiftly and in accordance with international fair trial standards. However, I would like to emphasize the importance of bringing all those implicated in the killing of Dionisio Díaz García to justice. I thus urge you to order a thorough investigation into these incidents.

I finally call on you to fulfill obligations to recognize the right of human rights defenders to carry out their activities without any restrictions or fear of reprisals as set out in the UN declaration on human rights defenders.
