Dear Mr. Perduca,

I am deeply concerned about the failure of the authorities in Serbia and in Kosovo to end impunity for enforced disappearances and abductions that occurred before, during and after the conflict. For instance, six men of the Dana family of Albanian origin, Afrim Dana, Albert Dana, Luan Dana, Labinot Dana, Kastriot Dana, Gëzim Dana, had disappeared after being forcibly taken from their home in Djakovica/ Đjakovë (Kosovo) by Serbian police forces on 10 May 1999. They were not seen alive again. Their bodies were found in Batajnica (Serbia) in January 2005.

In December 2008 Robert L. Dean, Acting Director of UNMIK Department of Justice, informed Amnesty International that the War Crimes Unit of UNMIK Police was investigating the enforced disappearance of the six men from Dana family and that all documents concerning the case were about to be transferred to EULEX prosecutors. Could you please tell me whether there has been any progress in this case.

I urge you to liaise with the Office of the War Crimes Prosecutor in Serbia in order to further investigate these cases. Finally, I would like to ask you to keep the relatives informed of any developments.
